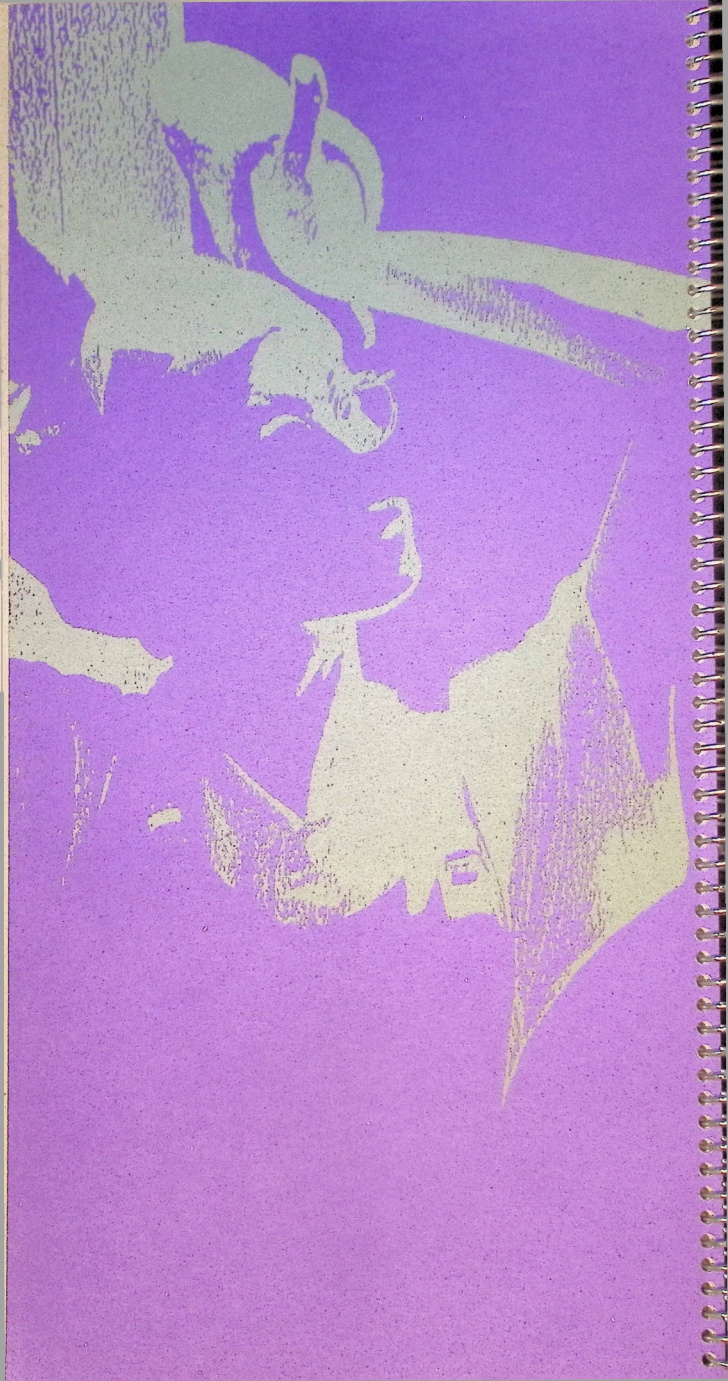





**Space Finder** is a guide to facilities for the performing arts in Seattle/King County. Organizations and individuals seeking space in which to perform or rehearse will find it a handy-reference. Venues well-suited for performances and rehearsals are grouped into four categories by seating capacity: **40-200 seats**, **201-500 seats**, **501-1000 seats**, and **1001 or more seats**. The **Table of Contents** reflects these divisions in addition to listing the facility's locale within King County (e.g., *South Seattle, Renton, Ballard*). For an alphabetical listing of facilities, please consult the **Index**. The **Map** gives locations for each facility. Listings are not sorted by discipline, so groups should contact the facilities directly regarding the appropriateness of venue for a given performing arts activity (dance, musical theatre, etc.).

Included in this booklet are **stage specifications**; type of **seating** and **number of seats**; type of **lighting**, **sound system**, and availability of **other stage equipment**; **rental policies**; **wheelchair**, **sight**, and **hearing accessibility**; and **contact information**.

Many of the venues will have the category **"Personnel Supplied"** or **"Technical Support."** Under these headings, most facilities responded with a simple "Yes" or "No," but some responded with a "Yes, required" or "No, required." "Yes, required" means the facility requires outside groups to use facility personnel; "No, required" means the facility requires a particular type of personnel and the outside group must supply that personnel.

The short statements that appear at the end of some listings were supplied by the facilities and do not reflect the views of the editors.

We attempted to include the **most commonly used, publicly accessible facilities** in the **Seattle/King County** region. Facilities which, at the time of publication, were made available only to groups with particular personal or religious affiliations were not included in the scope of this study. **Schools** that are listed are the primary venue for a community or are generally available for public use.

For your convenience, in the **Appendix**, we have alphabetically listed Seattle/King County **"Arts Service Organizations."** These are city agencies and nonprofit organizations that provide funding and other assistance to artists and arts organizations.

We hope you find this guide useful, and happy hunting.
